

CEA Terms of Business for Formal Qualifications

Standard Terms of Business

For Connex Academy's Formal Qualifications for Organisations, Schools and Individuals

Connex Education Academy Limited a company incorporated in England and Wales under company number 10311782 and whose registered office is at Unit A, Telford Court, Chester Gates Business Park, Chester CH1 6LT ("Connex Academy").

1. Definitions

- 'Accessed' means the commencement of any Formal Qualification or the viewing or loading of any Formal Qualification materials by a Learner or someone utilising a Learner's account;
- 'Cancellation period' means 14 days from payment of the course;
- 'Completion Deadline' means:
 - 3 months from payment for the qualification L2 Certificate in Special Educational Needs and Disability;
 - 6 months from payment for the qualification L3 Award in Education and Training;
 - 12 months from payment for the qualification L3 Certificate in Supporting Teaching and Learning;
 - 12 months from payment for the qualification L3 Certificate in Assessing Vocational Achievement;
 - 12 months from payment for the qualification L4 Certificate for Higher Level Teaching Assistants;
 - 24 months from payment for the qualification for L5 Certificate for Teaching English as a Foreign Language;
- **'Course Materials'** means the physical or downloadable materials relating to any Formal Qualification (in whole or in part) together with all revisions and updates made by Connex Academy, which may be in any format;
- **"Failed Learner"** means any Learners who do not complete their formal qualification by the agreed Completion Deadline unless they have had their exceptional circumstances extension approved in writing;

- **'Formal Qualification'** means any course that requires assessment by Connex Academy or a contracted third party before completion and certification;
- **"Funder"** means any organisation, corporate body, charity, or education and childcare setting that is paying for the tuition fees on behalf of the Nominated Learner;
- "Inactive Learner" means the Learner has not engaged in their e-portfolio for a period of 45 days;
- **"Individual Learner"**, means any individual who has paid their tuition fees directly to Connex Academy
- "Learner" means the person, organisation or corporate body to whom Connex Academy provides its services and / or a Formal Qualification (including but not limited to self-funding individual, Nominated Learners, education and childcare settings and other organisations funding courses for their nominated individuals;
- **"Nominated Learners"** means the individuals nominated to undertake the Formal Qualification in circumstances where the cost of the Formal Qualification where is funded by a Funder
- **"Tuition Fee"** means the amount determined by Connex Academy as payable in return for the services and formal qualifications;
- "Website" means <u>www.connex-academy.com</u>

Agreed Terms

- 1.1. Use of this website indicates that the website user has read and accepted these terms of business.
- 1.2. By accessing any Formal Qualification offered by Connex Academy, the Learner, and where relevant, their employer or funder, accepts these terms of business.
- 1.3. Payment of the Tuition fee is an offer to enter into a binding contract with Connex Academy on these terms of business. Connex Academy may accept or decline this offer at its absolute discretion.

2. Registration and Payment

- 2.1. Registration for a Formal Qualification must be completed online through the Connex Academy website and payments must be made in full or a deposit and an agreed payment plan be in place before the commencement of a course.
- 2.2. Any default under an agreed payment plan will automatically lead to suspension of the Learner or Nominated Learner's Formal Qualification portfolio. Failure to rectify the default within 14 days will lead to the Learner portfolio account being closed.
- 2.3. Funders and Nominated Learners are required to register their interest online on the Connex Academy website. Connex Academy will contact them to confirm payment arrangements and to confirm the details of any Nominated Learners.
- 2.4. Connex Academy reserves the right to refuse enrolment on any of its Formal Qualifications.

3. Formal Qualification Access

- 3.1. Following registration and payment under clause 2, Connex Academy will provide the selected Formal Qualification in accordance with the Formal Qualification description contained on the Connex Academy website.
- 3.2. On acceptance of an order for a Formal Qualification, Connex Academy will send a confirmation email and access instructions to the Learner. If this email is not received within 36 working hours the Learner should email <u>info@Connex-academy.com</u>
- 3.3. Formal Qualification Courses require Learners to complete an initial assessment to determine suitability for the selected course. Access to the course will not be granted until the assessment is successfully completed. If access to the course is not granted as a result of the initial assessment Connex Academy will cancel the Tuition Fee and issue a full refund.
- 3.4. Continued access to Formal Qualification Courses is conditional on the Learner's regular engagement with the programme. In exceptional circumstances, a pause of up to 6 months

may be agreed in writing. To request a pause, Learners must email <u>info@Connex-academy.com</u> heading their email as Exceptional Circumstances Request, requesting a pause to their qualification, with justification for their request.

- 3.5. Connex Academy reserves the right to suspend access or cancel orders without refund if the Learner is deemed by Connex Academy to be an Inactive Learner and if a pause has not been agreed. The Learner will be informed via email of their decision.
- 3.6. All courses must be completed by the Completion Deadline, Learners who do not complete their formal qualification by the agreed Completion Deadline and have not had their exceptional circumstances or extension approved in writing will be deemed as a failed Learner and their account will be closed.
- 3.7. In the event that the website or course access is unavailable at any time and for any period (for whatever reason) Connex Academy shall not be liable.

4. Nominated Learners

- 4.1. Any organisation or Agency funding a Nominated Learner will be required to confirm the identity and email address of the Nominated Learner who will participate on the selected course.
- 4.2. The Funder may request to transfer the course to another Nominated Learner within 45 days of payment for the Formal Qualification providing materials have not been accessed. Requests should be made to info@connex-academy.com. Connex Academy's will make a decision as to whether a Nominated Learner transfer can be approved and inform the funding organisation or agency via email. Connex Academy's decision is final.
- 4.3. Transfers will not be permitted more than 45 days after payment for the selected course regardless of whether the Course Materials have been accessed or not.

- 5.1. A digital certificate will be issued to the Learner on successful completion of a Formal Qualification Course. Successful completion includes approval by the relevant external exam board.

6. Cancellation

- 6.1. Learners may cancel their Formal Qualification order by emailing <u>info@connex-</u> <u>academy.com</u> with the wording 'Formal Qualification Cancellation' in the subject line.
- 6.2. Connex Academy will refund the Formal Qualification fee if a cancellation is received within 14 days of payment and the Learner has not accessed the Course Materials
- 6.3. Connex Academy aims to process eligible refunds within 30 days of cancellation.
- 6.4. Refunds will not be paid after Course Materials have been accessed.
