### How do we quality assure our trainers?

Connex Education Academy's Senior Mental Health Training is delivered through a series of online modules available on demand, supplemented by optional live sessions tailored to facilitate directed reflection and coaching according to individual needs. These are available on request.

Given the online delivery nature of our Senior Mental Health Lead course, all delivery content has been recorded, audited, and reviewed to ensure alignment with the learning outcomes mandated by the DfE Senior Mental Health Lead.



Learners are tasked with developing and refining a comprehensive school transformation roadmap and action plan as they progress through the course modules. These roadmaps are subsequently submitted to SMHL@connex-academy.com, following which a one-to-one coaching session is scheduled with one of our two trainers and the learner.

Virtual coaching sessions take place using Teams, with the learner's consent recorded for auditing purposes. These sessions are meticulously logged and audited for quality by our Managing Director at Connex Academy, stored securely.

Furthermore, all learners are invited to provide feedback via a post-course survey, with all comments, feedback, and suggested edits are monitored by the Managing Director of Connex Academy.

Quarterly standardisation meetings are held between the two expert trainers and the Managing Director to review any feedback received and reacted on any necessary further developments or edits to the Senior Mental Health Lead course.

# What training and support do our trainers get?

Our trainers undertake relevant CPD as required and as discussed in our standardisation meetings. Both trainers serve as consultants, delivering professional development both domestically and internationally.
